## THE SPEAKER AT THIS YEAR'S AGM

Our speaker at the AGM is David Forbes-Nixon, the man behind the purchase and restoration of Undershaw, the house built by Arthur Conan Doyle in 1897. David will tell us about his involvement with Stepping Stones, the remarkable school in Hindhead for children with learning difficulties. David, a wealthy philanthropist, was inspired to buy the old house after he found out that the existing premises occupied by Stepping Stones in Tower Road was running out of space. That accommodation, together with the Cookie Bar in Royal Parade, had been funded by another local philanthropic individual, Larry Sullivan. The story of the trials and tribulations of the re-birth of Undershaw is unbelievable and our speaker is well placed to tell us about it.

## **CHAIRMAN'S REPORT**

Dear Members.

How quickly the year has gone and it is again time to sum up the past twelve months.

We have had a few committee changes during the year. We have the pleasure of welcoming, Catherine Eyre and Cyndy Lancaster, whose skills and enthusiasm have already been most effective and beneficial to the Society. We were sorry to receive the resignations of Joe Macdonald and Michael Dover due to competing pressures on their time. After 10 years on the committee Diana Serman has decided to retire at the forthcoming AGM. She has kindly offered to continue managing the membership. Her diligence will be sorely missed however, particularly her interesting summer outings.

We are very keen to have the support of the membership particularly when we are taking an active part in town matters. Many of you offered supported when news of the obstruction of the footpath beside Lloyds Bank in the High street reached us. Although this path has been used by residents for generations it had never been registered. We, together with our Surrey County Councillor, raised petitions and alerted the Rights of Way staff to set the registration process in motion. At the time of writing nothing has been decided as the SCC local area committee is not meeting to discuss the matter until the end of September.

In July we learned that SCC were intending the following month to remove the characterful bracketed street lights in the High Street Conservation Area [without planning permission] and replace these with new lighting columns. The Society immediately enquired as to the necessity for doing this which would also add to the street clutter. At a subsequent meeting with SCC,WBC [who had previously approved the proposals], the contractor and HTC we learned that this was the final piece of work in a two year PFI contract entered into by SCC to renew street lighting throughout the county and maintain it for 20 years. We were also told that the existing lights had to be replaced for contractual, safety, and statutory compliance reasons and that the maintenance contract would only cover the new lighting. Work was due to start almost immediately and the Society was regrettably unable to negotiate a change from these established intentions. In view of this we have decided to invite the present Surrey County Councillor, to give us a brief update at our AGM's to keep us informed.

Over the past year the Society has continued to comment on planning applications which would have a significant effect on the amenity and character of the town and we hope that our comments have had some bearing on the planning decisions by WBC. Our planning team, devote a great deal of time to giving informed comments with the view of protecting the community and character of the town. It is often disappointing that our objections fail due to the Government reducing the grounds for doing so and the lack of an accepted Waverly plan. You as individuals can also send in your own comments, all of which adds weight to opinions.

We are pleased that another Blue Plaque will be unveiled in September connected with the Peasant Art movement. More about that at the AGM on November 20th and we look forward to meeting you all afterwards over a glass of wine in Haslemere Hall.

## **THE SUMMER PARTY**

Summer partygoers this year were treated to a fascinating insight into the architecture of St Christopher's church, on the green at the top end of Wey Hill. After delicious canapés (as always) and drinks, Mrs Frankie Gaiter, a past churchwarden at St Christopher's, gave us the background.

To accommodate a Haslemere population expanding rapidly with the coming of the railway, Charles Spooner, architect, craftsman, teacher and active socialist was commissioned to build a new church for the parish. It was completed in 1904, at a cost of £4,200.

Spooner was an adherent of the Arts & Crafts ethic with its focus on practicality and high quality materials. St Christopher's reflects this, built with beautifully crafted local stone and timber. And it has high quality interior fittings by Spooner, sometimes in collaboration with his wife, the artist Minnie Dibden Davison. Particularly noteworthy is the single barrel vaulted roof to both the nave and the chancel, with a beautiful floral and heart design. Sadly, two of Spooner's original features, a bronze statue of St Christopher and a hexagonal stone lantern have been stolen but exact replicas have replaced them since the theft.

Recently maintenance and upgrading work has been undertaken to ensure the church meets the needs of its twenty-first century parishioners. Churchwarden Clive Hawkins described the lengths to which the church office holders went to guarantee that the materials and building practices were a true reflection of the aesthetic to which Spooner aspired – even to the extent to having a 'bottom committee' to test the width, back rest angle and overall comfort of the beautiful new oak chairs.

By the end of the evening the weather was sufficiently kind to allow us the opportunity of viewing some of St Christopher's external features with its attractive chequerboard decoration on the west gable end and tower parapet. So ended another excellent Haslemere Society summer party, with it special mix of conviviality coupled with learning more about the beautiful town in which we are so fortunate to live.

#### PLANNING REPORT

The target/need to build 700 – 800 houses in Haslemere in the next 15 years is exercising a lot of thought on where to build and the effect on local infrastructure and character of the town. Both the new Waverley Local Plan and the Neighbourhood Plan which will set out how this development can be achieved are still in preparation and until these are approved there is a lack of protection or guidance on how to deal with applications for large scale housing development; Sturt Road being an example.

Another application for a large housing development at Chasemore in Hindhead, which The Society objected to, and a public consultation on residential development of the Andrews site at Hindhead are indicative of the pressures from developers following up on this announced target.

Recently there have been examples of poor quality design in planning applications for housing at Coombe Lea, Critchmere Lane and the conversion of the Police Station. The Society has put forward strong reasoned objections to such poor and inappropriate design for these applications and we are pleased to report that these have been refused by WBC as well as Marston Lodge adjacent to the Weydown Road industrial estate which we were unable to comment on within the prescribed time limit. At the time of writing a revised design for the Police Station development has just been submitted by the developer but this fails to address all our concerns.

The Society supported the application to convert and develop Undershaw in order to arrest the continuing decay over the very long planning and litigation period and to return the buildings into useful and functioning premises for the Stepping Stones School. Work on this is well underway and it is disappointing that a Judicial Review of WBC's planning approval has been granted. We also note that a Judicial Review of the planning approval of the Sturt Road application has upheld WBC's approval. These reviews are very costly and time consuming.

The Society learned of the intention to erect new lighting columns in the Town Centre Conservation Area only days before commencement of the work and immediately called for a meeting with SCC to see if the characterful bracketed lights could be retained and prevent the increase in street clutter which would result. Unfortunately, it proved impossible to alter the intentions of a major contract entered into by SCC more than two years ago for new county wide lighting and a 20 year maintenance programme. However the choice of lighting columns and their positioning blend reasonably well into the High Street.

### **BLUE PLAQUES**

The society will be unveiling another blue plaque in September. This time we are celebrating the Peasant's Arts Industries, which is an important and often overlooked part of Haslemere's heritage. Committee member Catherine Eyre has taken a keen interest in the movement and has become a leading authority on its history.

Jackie Gray, the owner of Greenbushes in Foundry Lane will be erecting the plaque. Her house was Luther Hooper's weaving house which was at the centre of the movement.

Greenbushes was established in the late 1890's. Inspired by the Arts & Crafts Movement, The Peasant Arts Society's founders, Joseph King MP and his wife Maude ,Godfrey Blount and his wife Ethel (Maude's sister) and Greville MacDonald (Joseph King's cousin) were writers and artists who all had a significant impact upon the local area. The movement promoted traditional crafts in the face of the emergence of mass produced consumer products. A number of their finer works are held in a collection at the Victoria and Albert Museum.

## TREASURER'S REPORT

The results for last year showed a substantial improvement in our finances, with a profit of £881 compared with a loss of almost identical proportions in 2014.

Subscription income increased by nearly £1,000 due, in part, to the rise in the annual subscription which came into effect at the start of the year and also to the welcome addition of 4 new life members. However, our total membership has fallen by about 10% over the year and if this trend continues there may be cause for some concern in the future. The higher subscription income was partially offset by a fall in the surplus from members' events. In 2014 we held a very successful dinner to celebrate the life of Sir Robert Hunter and there was no comparable activity in the year just ended.

Total expenditure of £3,477 is substantially lower than the previous year, when we incurred significant costs for updating our website and the purchase of additional stationery to reflect the changes in subscriptions. Our costs in 2014/15 are broadly in line with the norm for earlier years and this includes a contribution to Waverley Borough Council for their Design Award scheme.

Our cash position has improved to reflect the profit during the year and we retain our contingency fund of £10,000 which is held on short term deposit.

The accounts are set out below and a signed copy, audited by our Honorary Auditor Mrs. Clare David, will be available to members attending the Annual General Meeting.
